**GENERAL INFORMATION:** **Flocculate** is a calcium product for commercial use only and may be used on soils for all field grown crops. **Flocculate** aids in water penetration, irrigation efficiency and reduction of sodium buildup in the soil. **Flocculate** is to be used only in soils where insufficient calcium levels are indicated by laboratory analysis and is to be used as a supplement in an overall nutrient program. It may be applied alone, with other fertilizers, or in tank mixes containing pesticides.

**DIRECTIONS FOR USE:** **Flocculate** should only be applied in accordance with the recommendations from a professional crop consultant, based on a soil analysis and specific for the crop to be grown. Best results are achieved by ground application with a sprayer, or through an irrigation system based on, or in accordance with, the recommendations of a professional crop consultant.

**Rate:** Apply **Flocculate** at 2 to 5 oz./Acre in 20 gallons of spray/Acre. Do not exceed a maximum rate of 5 oz./Acre, or

deviate from 20 gallons of spray/Acre unless recommended to do so by a professional crop consultant or representative of **AG Technologies LLC**.

**CAUTION:** Use of **Flocculate** on crops other than those recommended by a professional crop consultant or representative of **AG Technologies LLC** may result in serious injury to the crops(s).

**TANK MIXING:** Gradually add **Flocculate** to the tank while filling with water. Do not pour into an empty tank or when tank is completely full. Agitate the contents of the tank during filling and application. Mix with clean water only. Foreign substances may cause failure. When mixing, fill tank 3/4 full. Sprinkle product into tank with the agitator running. **Flocculate** can also be mixed prior to application in a 5-gallon bucket of warm water and then added to the tank.

**Storage Instructions:** Keep **Flocculate** in its original container and keep container tightly sealed. Store in a cool dry area, avoiding high temperatures, humidity, and acids. Keep out of the reach of children and keep animals away.

**Container Disposal:** Do not contaminate water, food or feed by storage or disposal. Dispose of packaging according to state and local authorities. If burned, stay out of smoke.
